QNG - Qualitätssiegel Nachhaltiges Gebäude

The Qualitätssiegel Nachhaltiges Gebäude (Quality Seal for Sustainable Buildings), developed by the German Federal Ministry for Housing, Urban Development and Building (BMWSB), defines requirements for the ecological, socio-cultural, and economic quality of buildings. The Sentinel Holding Institut evaluates construction products in accordance with QNG requirements for certification and awards the QNG ready label. Compliance with the QNG standard is a prerequisite for eligibility for the KfW funding programme. For certain product groups, the QNG currently has no specific requirements defined. Although classified as not assessment-relevant, these products remain suitable for QNG-certified projects.

Konformitätserklärung RoHS

Sehr geehrte Damen und Herren,

die Elektro- und Elektronikgeräte-Stoff-Verordnung (ElektroStoffV, zur Umsetzung der Richtlinie (EU) 2015/863 der Kommission vom 31. März 2015 [RoHS II]) verbietet das Inverkehrbringen von Elektro- und Elektronikgeräten im Sinne des § 2 Nr. 1 der ElektroStoffV, wenn darin homogene Werkstoffe verarbeitet sind, die einen oder mehrere der in der Verordnung genannten Stoffe in einer höheren als der zulässigen Höchstkonzentration enthalten.

Betroffen sind zum aktuellen Zeitpunkt Blei, Quecksilber, sechswertiges Chrom, polybromiertes Biphenyl (PBB), polybromierte Diphylenether (PBDE), Di(2-ethylhexyl)phthalat (DEHP), Butylbenzylphthalat (BBP), Dibutylphthalat (DBP) und Diisobutylphthalat (DIBP), die je homogenem Werkstoff die zulässige Höchstkonzentration von 0,1 Gewichtsprozent nicht überschreiten dürfen, sowie Cadmium, das nur bis zu einer Höchstkonzentration von 0,01 Gewichtsprozent je homogenem Werkstoff enthalten sein darf.

Die von Gira hergestellten Elektro- und Elektronikgeräte im Sinne der ElektroStoffV beinhalten keine der dort genannten Stoffe in einer höheren als der zugelassenen Höchstkonzentration, unter Berücksichtigung der Ausnahmen der Anhänge III und IV der RoHS-Richtlinie.
